1. RESOLUTION AMENDING INTERMUNICIPAL AGREEMENT WITH THE TOWN OF HURON FOR PORT BAY WATER DISTRICT -

The following resolution was presented by Kim Park, moved by Scott Gregg, seconded by Adam Ellis,

WHEREAS, the original intermunicipal agreement with the Town of Huron had no provision for the billing/reimbursement of expenses already incurred by the Town of Huron, in particular reimbursement of legal expenses; and

WHEREAS, Wolcott, being the lead agency for the district, is the responsible party to submit billing to Rural Development; and

WHEREAS, Rural Development will only recognize the Town of Wolcott as the authorized billing agent; and

WHEREAS, the intermunicipal agreement must be changed to allow Huron to submit expenses previously and presently incurred to the Town of Wolcott for reimbursement with Rural Development funds upon presentation of all necessary documentation,

NOW, THEREFORE BE IT RESOLVED, the Supervisor is authorized to sign the agreement amending the intermunicipal agreement with the Town of Huron to reflect the above stated changes.

2. RESOLUTION FOR AWARD OF CONTRACT TO WAYNE COUNTY WATER AND SEWER AUTHORITY FOR CONSTRUCTION OF WOLCOTT/HURON JOINT PORT BAY WATER IMPROVEMENTS -

The following resolution was discussed by the Board but tabled until their next meeting.

WHEREAS, USDA-Rural Development-Rural Utility Service (RUS) has approved the construction of the Wolcott/Huron Joint Port Bay Water Improvements (the "Project") by the Wayne County Water and Sewer Authority ("WCWSA") in accordance with the design plans submitted by the Project Engineer (MRB Group, P.C.); and

WHEREAS, said Project Engineer has reviewed the Itemized Propo-sal ("Proposal") submitted by WCWSA in conjunction with the Project budget, and has recommended that adequate funds are available to con-struct the Project based on the Proposal; and

WHEREAS, said Project Engineer has prepared and submitted a No-tice of Award to be executed by the Town and the WCWSA,

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Wolcott, Wayne County, New York as follows:

Section 1. The Town Board hereby awards the Contract for construction of the Project to the WCWSA for the Total Base Bid plus Conditional Items at a cost of \$1,232,535.00.

Section 2. The Supervisor of the Town of Wolcott is hereby authorized to execute the Notice of Award and the formal Construction

Agreement for the construction of the aforesaid water distribution system and related appurtenances.

Section 3. This resolution shall take effect immediately.
